Marriott Groundbreaking



The 2020 Census will help decide how many billions of dollars will reach our families/communities. Census data also determines funding allocations for our schools, child care programs, road maintenance, social assistance programs, determines where new hospitals are built, improves our health programs and increase jobs and business opportunities. As you can see the data obtained from the Census helps in many aspects of our daily lives..... so please take time to complete the Census questionnaire when you receive it in the mail.

Wage Statements and Personnel File Requests



Introduction

A consistent and telling first sign of possible litigation can appear casually, and under the guise of a simple request. Current and former employees have the right to make a request for their wage statements and personnel file. However, as is now often occurring, that request comes not from the employee, but from that employee's legal counsel. This can be a tell-tale sign that a legal claim is coming, making it important that employers know how to properly and promptly comply with such requests.

Wage Statement Requests

California Labor Code § 226 requires, upon written request from a current or former employee, an employer furnish or make available itemized wage statements within twenty-one (21) days of receiving the request. This request can require furnishing up to the prior three years of the employee's wage statement history. The Labor Code provides for a \$750 fine for an employer's failure to timely comply with such a request.

However, the real monetary penalties can stem from violative wage statements. Each and every wage statement must include: gross wages earned, total hours worked for the pay period, the number of piece-rate pay earned (if any), all deductions made to the wages, the net wages earned, the dates of the pay period, the hourly rate of the employee, the name and address of the employer, and either the name and last four digits of the employee's social security number, or the employee's unique employee identification number.

It is imperative employers comply with the Labor Code requirements for wage statements, as failure to comply can lead to costly and lengthy litigation. Once you ensure your wage statements are lawfully maintained, complying with a wage statement request becomes less stressful and significantly easier.

Personnel File Requests

Labor Code § 1198.5 provides current and former employees with the right to either inspect or receive a copy of their personnel records upon written request. An employer only has thirty (30) calendar days to comply with this request. Unfortunately for employers, personnel records are not defined by the Labor Code, making it often difficult to comply with such a request.

The Division of Labor Standards Enforcement (DLSE) has provided some guidance on what categories of documents make up a personnel file but does not provide an exhaustive list. Documents which likely constitute personnel records include: employment applications, payroll authorization forms, disciplinary action (write-ups, warnings, etc.), termination documents, leaves of absence requests, training records, performance reviews, and attendance records.

While neither the law, nor the DLSE, specify all of the documents that are included under the umbrella of a personnel file, the Labor Code does specify that the following do not need to be included: records relating to the investigation of a possible criminal offense, letters of reference, and ratings, reports, or records that were (a) obtained prior to the employment of the employee, (b) prepared by identifiable examination committee members, or (c) obtained in connection with a promotional examination.

Determining what to include and what to exclude in a personnel file request can be a daunting task for employers unfamiliar with such requests, especially doing so within 30-days' time. Despite these challenges, it is important to ensure you timely provide a copy of (or an opportunity to inspect) a personnel file to ensure you do not face the \$750 penalty for failure to comply with the request.

Labor Code § 432 Requests

It is also becoming more common to see a Labor Code § 432 request in addition to the standard wage statement and personnel file request. Labor Code § 432 provides that an employee or job applicant is entitled to a copy of any document they signed relating to their employment upon request. One reason this is starting to be thrown into wage statement and personnel file requests in an attempt to capture some documents that may not ordinarily be required to be provided in a standard personnel file request.

For example, some employers require employees to initial or sign their time entries per workweek or pay period. While time records are not included in the DLSE guidance as constituting personnel records, a request under Labor Code § 432 could arguably now include these records. This only adds the confusion of employers on how to appropriately comply with wage statement and personnel file requests. As such, if you receive a Labor Code § 432, contacting your legal representative may be necessary to ensure you do not over-include, or under-include, documents you intend to provide in response to a request.

Conclusion

Ensuring compliance with the California Labor Code can be a daunting task. As wage statement and personnel file requests continue to increase in number, it is imperative employers review and update their employment practices accordingly.
