

#### **Employers Beware: New Employment Laws That Need Attention**



California Governor Gavin Newsom signed into law many new pieces of legislation prior to the October 13, 2019 deadline. The following is a brief summary of a few of the major employment laws recently passed.

#### Arbitration Fees - Senate Bill 707

For employment arbitration, the drafting party (i.e. the employer) is required to pay all fees and costs of the arbitration proceedings. Senate Bill 707 creates significant consequences

where the employer fails to pay arbitration fees and costs in 30 days of such fees being due. If an employer fails to meet this 30-day requirement, that employer will be deemed in material breach of the arbitration agreement, is in default of the arbitration, and waives its right to compel arbitration.

A major consequence of being deemed in material breach of the arbitration agreement is that the employee could withdraw from the proceedings and proceed with their claims in court. Further, if an employee does withdraw, their claims will "relate back" to any claim brought in arbitration. This would allow that court case to proceed provided the arbitration claims were within the statute of limitations, regardless of if the court case is now well-beyond the statute of limitations. Finally, the court could also impose monetary sanctions on the employer for being in material breach of the arbitration agreement. This means that employers need to be aware of the cost of arbitration, and ensure payment within 30 days, to avoid these consequences.

#### Independent Contractors - Assembly Bill 5

In 2018 the California Supreme Court, in Dynamex Operations v. Superior Court of Los Angeles, completely uprooted the manner in which employers can designate workers as independent contractors. Since then, employers have faced the challenge of properly classifying their workforce in compliance with the "ABC" test established in Dynamex.

Assembly Bill 5 is the last chapter of the book that started with Dynamex. This new law codifies the "ABC" test and sets out a list of occupations exempted from this test. The exempted occupations, which will use the pre-Dynamex, Borello standard, are: licensed insurance agents, certain licensed health care professionals, registered securities broker-dealers or investment advisers, direct sales salespersons, real estate licensees, commercial fishermen, workers providing licensed barber or cosmetology services, and others performing work under a contract for professional services, with another business entity, or pursuant to a subcontract in the construction industry.

Misclassifying workers can come with huge ramifications. Thus, if you employ or are planning to employ independent contractors, it is vitally important to familiarize oneself with Dynamex, the "ABC" test, and Assembly Bill 5.

#### No-Rehire Provisions in Settlement Agreements - Assembly Bill 749

Historically, employers have included no-rehire provisions in settlement agreements with former employees. These provisions essentially preclude a former employee from ever obtaining employment with that employer in the future. These provisions have proven to be especially useful for larger companies who want to ensure a

former employee is not re-hired at different branch or location potentially unfamiliar with the conflict that previously arose.

However, Assembly Bill 749 disallows the use of those provisions. All settlement agreements entered into on or after January 1, 2020 can no longer include a norehire provision, and if that provision is included, it will be deemed void.

#### **Employment-Related Administrative Complaints - Assembly Bill 9**

The Department of Fair Employment and Housing (DFEH) provides administrative remedies for employees who believe they have a claim against their employer. This includes all employment claims under the Fair Employment and Housing Act (FEHA). Prior to Assembly Bill 9, employees had one year from the alleged wrongdoing to file an administrative claim with the DFEH. Assembly Bill 9 extends this period to three years. This means that employees, starting January 1, 2020, will have three years to bring claims for discrimination, harassment, retaliation, and more.

#### <u>Lactation Accommodation Requirements - Senate Bill 142</u>

Senate Bill 142 expands the lactation accommodation obligations of most employers. Employers with 50 or more employees will now have to adopt and distribute a mandatory lactation policy. Further, lactation rooms must comply with certain requirements, such as close proximity to a sink and refrigerator. This law also increases an employer's liability for failing to provide reasonable break time for employees to express breast milk.

Employers with less than 50 employees can attempt to seek an exemption from this new law by showing an undue hardship, otherwise will also have to meet the new obligations under Senate Bill 142.

#### <u>Discrimination Based on Hairstyle - Senate Bill 188</u>

Under the FEHA, it is unlawful to engage in specified discriminatory employment practices, including hiring, promotion, and termination based on certain protected characteristics, such as race. Senate Bill 188 amends the definition of race under the FEHA to include "traits historically associated with race, including, but not limited to, hair texture and protective hairstyles."

This is an important bill for employers to take note of because many dress-code, appearance, and grooming policies may need to be amended to ensure compliance under this law. Managers and supervisors should also be apprised of this new law to prevent future violative hiring or disciplinary practices by managers and supervisors unaware of these changes in policy.

#### **Conclusion**

Keeping up to date with new employment laws can be challenging in California. However, over the next few months it is imperative employers review the new laws that were signed into law this year as many of these laws go into effect January 1, 2020.
