



An evening at the Symphony is always an enjoyable experience. At each concert, in partnership with the Downey Arts Coalition, the Symphony presents a themed exhibit of work by local artists. Doors open early so patrons can enjoy the art. The comfortable size of the Theatre keeps the audience close to the musicians and music. Refreshments are available before each concert and at intermission. Everyone is warmly welcomed by Symphony Board members, and the conductor and musicians enjoy meeting the audience after the show. Ticket prices are affordable with reduced prices for students, and free parking is available adjacent to the Theatre.

## **Legal Corner**

#### Hanging in the Balance: California's Pending Legislation that May Affect Employers

The California Legislature concluded its working year on September 15, 2017. That meant that hundreds of bills relating to labor and employment issues made their way to Governor Brown's desk. The Governor has to decide whether to sign these bills into law by October 15 or issue a veto. While the array of proposed legislation has the potential to dramatically impact California's rules surrounding the workplace, this article provides a brief overview of some of the bills certain to turn employers' heads should they become law.

#### SB 63 – New Parent Leave

Currently, California employers with 50 or more employees are forbidden under the California Family Rights Act ("CFRA") from refusing to grant an eligible employees' requests to take up to 12 weeks of unpaid protected leave to bond with children born to, adopted by, or placed for foster care with, the employee. This bill would increase the number of employees eligible for such leave by providing 12 weeks of unpaid protected leave for bonding to employees working for employers with as few as 20 employees. Of note, the bill has language incorporating the regulations interpreting CFRA so that those regulations would apply here as well.

#### AB 106 – Salary History Information and Inquiries

This bill has both offensive and defensive components that would create a playing ground slanted in favor of job applicants. First, the offensive component provides applicants with the ability to obtain pay scale information from the employer for the position of interest upon reasonable request by the applicant. On the other hand, the defensive component of the bill prohibits what employers can do and consider with respect to an applicant's salary history information. Specifically, employers would be prohibited from seeking information about an applicant's salary history. Employers would also be prohibited from relying upon an applicant's salary history information in determining whether to extend an offer of employment to the applicant. Of course, under the bill, an applicant can voluntarily provide an employer with their salary history information. In that situation, an employer may lawfully consider and rely upon this information.

#### SB 306 – Retaliation Claim Procedures

Retaliation claims can arise in an instant, especially due to the simple fact that people are behind the decision-making process to fire, demote, or otherwise take an adverse action against an employee engaged in or who has engaged in protected conduct. It is no surprise then, that this bill requires employers' full attention. If signed into law, this bill would no longer require the complainant employee to file a claim of retaliation with the Division of Labor Standards Enforcement ("DLSE") before the Labor Commissioner could investigate an employer for unlawful retaliation. Rather, the Commissioner would be authorized to investigate an employer on its own initiative during the course of another matter under the DLSE's purview. What is even more dramatic is the bill's provision allowing for injunctive relief (likely reinstatement of the employee) before it is determined whether the employer even retaliated in violation of the law.

#### <u>AB 1008 – "Ban the Box"</u>

This bill would make it unlawful for employers with just five (5) or more employees to consider an applicant's conviction history before making a conditional offer of employment. Once the conditional offer of employment has been extended, employers are permitted to conduct a conviction history background check. An employer ultimately choosing to deny employment to an applicant based on his/her conviction history would be required to make an individualized assessment on whether the applicant's conviction history is a justifiable basis to disqualify the applicant from employment. An employer's obligations do not end there. An employer would then be required to provide the applicant with written notice of the decision, the conviction(s) serving as the basis for the decision, and a copy of the conviction history report, if any. Employers would then have to give the applicant five (5) business days to respond before a final decision could be made.

Failure to comply can result in liability in accordance with any applicable law or local ordinance.

#### AB 1209 – Gender Wage Differentials

This bill would create two new obligations for employers – data collection and data reporting with respect to gender wage differentials. Notably, this bill only applies to employers with 500 or more employees. Beginning on July 1, 2019, and every two years after, covered employers would be required to collect data on the average and median wage differences between male and female exempt employees in California. The following year, on July 1, 2020, employers would be required to report this information to the Secretary of State. The reporting requirement is also on a biennial basis. The Secretary would publish this information on a publicly available website.

While a reported gender wage differential would not be a violation of the Labor Code in itself, employers should be prepared for the ripples that this bill may cause. To avoid public scrutiny over seeming gender inequality, employers may find themselves raising the salaries of many of their exempt employees. This is especially so in light of the recent class action lawsuit filed against one California employer, Google, Inc., for alleged violations of the California Equal Pay Act.

Employers should take notice of not only these bills, but all those awaiting Governor Brown's signature. Avoiding exposure to employment related issues is an endeavor that can often be accomplished by staying informed of new developments and being proactive with respect to one's legal obligations.

The 5th annual Downey (CA) Dia de Los Muertos Art Festival, scheduled for Sunday, Oct. 29th, 2017, in and around the Downey Theatre, 8435 Firestone Blvd., downtown Downey, is again presenting "Urban Art Alley," a favorite with the 20,000 expected attendees who savor the abundant art, dance, film, music, food, shopping, and crafts, most of it themed to Day of the Dead. This year, "Urban Art Alley" features two works by Martin Sanchez, who has exhibited at the Festival for the past four years; his whimsical, oversized sculptures are event highlights. On display will be a 22' high "Skeleton on a Bicycle" which has been exhibited at the Riverside Art Museum, and a new work he's crafting for the Downey event.

Originally from Michoacán, Mexico, Sanchez has integrated Southern California culture into his work, creating art out of the castaways of urban life, repurposing items that range from bottle caps to rusted bicycle wheels to seashells. Despite the rough raw materials, Sanchez's work is light and charming.

New to Urban Art Alley this year is the "Parade of Catrinas." Catrinas are familiar icons of Day of the Dead: lady skeletons in fancy dresses and elaborate hats. Designed by Ricardo Soltero, the "Parade" of larger than life, 10' tall, one-of-a-kind catrinas dazzle with colorful dresses and wild hats.

Soltero, a native of Nayarit, Mexico, began his artistic life at five-years old, helping his grandmother make paper flower wreaths to sell and decorate for their local Day of the Dead celebration.

While still in his teens, Solteros's family relocated to Baja Mexico where Roberto enrolled at the Casa de la Cultura, broadening his studies to include, dance, singing, painting, and theater, where he acted, and created sets and scenery.

Using paper mache, recyclable materials, wood and Styrofoam, Soltero's works have been displayed at Hollywood Forever Day of Dead, The Autry Museum, Denver Botanical Gardens and more. His work has also been shown in NY, Chicago and Mexico City.

Additional "Urban Art" exhibits include "car altars" -- traditional altars displayed in the trunk or roof or inside an automobile. "Trunk altars," have been displayed in San Antonio, San Diego, and Los Angeles, where the altar is often combined with a classic or vintage auto.


Other Festival attractions include continuous performances in the 738-seat Theater by the region's top ballet folklorico troupes. Films include a free showing of "Book of Life"; traditional altars and luminarias will be on display in the patio and foyer of the main Downey Library, which included in the Festival footprint.

Outside, the garden-like zocalo offers live romantica and bolero music, and in the patio, hands- on arts and crafts with master artisan demonstrations and guidance.

The Theatre back lot houses food trucks with a variety of cuisines; almost 50 vendors sell quality Day of the Dead related art and merchandise.

The annual Festival is a production of the City of Downey and the Downey Theatre, and is a reflection of their commitment to the traditions and art that reflect the Southland's Mexican/Latin roots.
